PROOF OF KARNALYTE 2018 VOTE FRAUD NOT GOOD ENOUGH FOR REGULATORS?

Following an inquiry to iTrade regarding changes to his personal votes cast at the 2018 KRN Annual Meeting, Tom Villeneuve received confirmation of his vote changes that KRN management orchestrated to win an “uncontested” vote for the entire Board of Directors. A WITHHOLD vote over 50% would have resulted in the entire board resigning.

Since it seems to be hard to connect I will email you the information I was able to retrieve. I will be out of the office tomorrow and I want to get this to you today.

I would like to clarify something that I think was communicated incorrectly previously.

I believe the understanding you had after speaking to Omar was that only one of your accounts had a vote submitted.

This is not correct.

- Each of your accounts were voted (and voted the same) – it appears that you “Abstained” meaning that you were going to go to the meeting to vote. (see screenshot below).
- Below you will also find all of the control numbers.
- I was not able to get a copy of the second letter that you said was mailed but I’m sure you can get this from the company or the transfer agent
- The transfer agent is AST Trust Company
- The tabulation agent was D.F King (which means D.F King tabulated the results of the proxy vote)

This is all the information that I will be able to provide to you. If you need further information you might want to check with either the transfer agent or the tabulation agent. I have omitted your account numbers from the screenshot below for security reasons but I am sure you can determine which account is which by the number of shares in each.
